
1-a BOT Goals

- Strategic Goal: Enhance Institutional Fundraising and its established goal of \$5.5 million.
- Goal Achievement Status: YTD (close of 4th Quarter) \$5.83 million in cash gifts and \$10.2 million in total cash and pledges.

Fundraising Initiatives & Gifts:

Giving to Florida A&M University has increased by 81.76% over last year.

- Multi-million dollar gift and six figure bequests (\$5 million major gift; over \$250,000 in planned gifts)
- >2014 Faculty & Staff (\$194,589.22) [Cash & Pledges]
- 10for\$10 Giving Campaign raised \$183,668.00 in cash and pledges from 2,955 donors





1-b 90-Day Plan

A 90-Day Plan will consist primarily of next steps in determining the operational needs of the Division of University Advancement and the core funding needs of Florida Agricultural and Mechanical University.

The plan will include a review of operations: fiscal, budget and planning considerations.





2-a Foundation Operations

- The University's endowment stands at <u>\$123,844,922</u> as of May 31, 2015.
- The office is in the process of fiscal year-end closing and is preparing for final field work related to the external financial statements audit.






4. Rattler Boosters
