NOTICE OF PROPOSED NEW REGULATION

REGULATION CHAPTER TITLE: Academic Affairs **REGULATION CHAPTER NO.:** Chapter 4

REGULATION TITLES AND NUMBER: College and School Governance (4.002)

SUMMARY OF REGULATION: The amended and renumbered Regulation authorizes each school, college and/or academic unit to establish internal governance procedures which must be followed by faculty and staff of the school, college and/or academic unit. These procedures must be approved by the Vice President for Academic Affairs prior to submission to the FAMU Board of Trustee and must not conflict with other University regulations, policies or procedures. In addition, the Regulation provides where such procedures may be obtained and makes technical (grammatical, punctuation) changes.

AUTHORITY FOR REGULATION: Article IX, Florida Constitution, Board of Governors Regulation Development Procedure dated July 21, 2005, Board of Governors Resolution Adopted January 7, 2003, Sections 1001.74(4) and 1001.74(2), Florida Statutes.

UNIVERSITY OFFICIAL INITIATING THIS REGULATION: Dr. Debra Austin, Provost and Vice President for Academic Affairs.

4.002 College and School Governance.

Each college, school and/or academic unit within the University is permitted to establish its own procedures of internal governance. These procedures should be developed by the faculty, staff and appropriate administrators. ~~provided such procedures do not conflict with other University rules and procedures and are approved by the Vice President for Academic Affairs.~~ Such procedures should not conflict with other University regulations, policies and procedures and must be approved by the Vice President for Academic Affairs. All administrators, faculty and staff members ~~assigned to a particular college, school and/or academic unit~~ are expected to adhere to the established internal procedures of governance. The procedures are available in the Office of the Dean of the respective college or school and in the office of the appropriate officer in charge of an academic unit that is not a part of a college or school.
