# a. Review of Endowments by FAMU Division of Audit and Compliance

VP Maleszewski advised that they are in the process of developing their annual audit work plan for the coming fiscal year that begins on July 1. The audit of the FAMU Foundation is one of the items that is added

to their work plan that will be submitted, along with their meeting materials, to the FAMU Board of Trustees for approval at their Board Meeting in June. The FAMU Division of Audit will be prepared in the coming fiscal year to take up the audit that has been requested. VP Maleszewski requested that the FAMU Foundation Board advise if they have any guidance or additional clarity that could be provided on the scope of the audit; this would be helpful to his office.

#### **New Business**

# a. Preparation for the Audit of FY 2020-2021 Financial Statements

The Board received a copy of the Arrangement Letter and Planning Communications that was prepared by the FAMU Foundation auditors, BCA Watson Rice. Included in the documents were the audit Objective and Scope, Responsibilities of Auditors and Management, Availability of Records, and the proposed timeline.

Mr. Ronald Thompkins provided details, listed below, regarding the timeline.

- Preliminary work will commence in mid-June for a week
- Mid-July, they will return for final work that will last approximately six weeks
- Plan to wrap up the audit the end of August
- Will provide the audit to the FAMU Foundation the last week in August or the first part of September

Mr. Thompkins advised that the Form 990 is due November 15.
